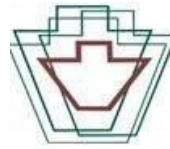

Our members range from senior housing, home health industry, health and medical services, referral agencies, technology-based organizations, professional services such as legal and financial and other community-based service organizations. Members include both individuals and organizations and for-profit, non-profit and government agencies.

Our membership dues are based on a calendar year and run from January through December. Dues start at \$75 for a “One Person Membership, One Company, ONE Chapter for a year.” We also have multi-member and multi-coalition memberships. Most of the funds we raise through membership go to our Joint Coalition Assistance Fund.

The Denver Senior Coalitions’ Joint Coalition Assistance Fund (JCAF) receives monies that have been paid as dues to the four Denver Senior Coalition Chapters. Our non-profit members are invited to apply for these funds through an application and vetting process. At our December holiday meeting of the Denver Senior Coalitions, this senior professional networking group shows their holiday spirit, and we give away Joint Coalition Assistance Fund awards to deserving organizations that serve older adults. These organizations are selected through an application process and a review process conducted by our board members.

The 2022 awards went to Audio Information Network of Colorado, Denver Inner City Parish, Senior Housing Options, and Sunshine Home Share Colorado. Each of these organizations filled out an extensive grant application and according the JCAF application guidelines, they each had a program they wanted to fund that directly benefited older adults in the greater Denver area.
